The mixture has a low chromate content. After adding water the soluble chromium (VI) content is at most 2 ppm on the dry product.

To maintain a low chromate content, store it properly, in dry conditions, respecting the maximum expected storage terms.

The percentage of respirable crystalline silicon oxide is less than 1%. Therefore the product is not subject to identification. However it is advisable to use respiratory protection.

difficulty, asthma) keep the victim in a comfortable position for breathing. If necessary administer oxygen. If the subject stops breathing, administer artificial respiration. Get medical advice/attention.

Rescuer protection
